Everyone is enjoined to actively participate in the forthcoming **VSU Institutional Accreditation** on **November 22 – 26, 2010.** The Accreditors are scheduled to arrive on November 21 and will depart on the  $27^{th}$ . Attached is the general schedule of activities.

Relative hereto, all faculty and staff are requested to postpone their travels during the conduct of the Institutional Accreditation. Likewise, the actual teaching load and schedule of classes of all faculty for the 2<sup>nd</sup> Semester SY 2010-2011 should be submitted to the OVPAA for reference of the Accreditors during the class observation. All faculty must attend to their classes on time and be ready with their class record, course syllabus/course outline and other teaching materials (e.g. powerpoint presentation).

As part of our general preparations, all departments/institutes/centers must do the following:

- clean assigned areas/experimental sites
- install labels of offices/classrooms, laboratories and experimental sites/extension projects
- assign faculty/staff to man the projects during the visit

Everyone is expected to know by heart the vision and mission of VSU as well as the vision, mission, goals and objectives of their respective department/college.

A random interview may be conducted by the Accreditors hence the students, faculty and staff are expected to be polite when interviewed. If you are identified to be one of those who will be interviewed, kindly participate and report on time to the designated venue, probably at the CCE Bldg. The schedule of panel interview is between November 23 to 25.

Your active involvement in this important activity of our university, being the first state university to be accredited as a teaching and research institution, is highly requested.
