A supervisor is one of the most important positions in the organization, one that deserves support to ensure success in the organization's pursuit of excellence. She/he models excellent interpersonal communication; inspires a common vision; demonstrates respect for a diverse community; encourages teamwork and collaboration; and coaches, evaluates, and develops people in alignment with the goal of the organization.

As part of the key activities identified in the CY 2023 Learning and Development (L&D) program, the conduct of the Supervisory Development Course Tract II and III will be held on October 9-13, 2023 via webinar mode. The general objectives of the training are the following:

- 3. Earn the hours of supervisory and leadership training prescribed by CSC for appointments to supervisory and managerial positions

As a finisher of the Supervisory Development Course Track I in the previous years, you are strongly encouraged to participate in this five-day webinar to be able to complete the entire three-track courses. The Civil Service Commission - Reg VIII will facilitate this webinar.
