The AO 25 Inter-Agency Task Force recently released Memorandum Circular No. 2022-1 dated March 24, 2022 entitled "Guidelines on the Grant of the Performance-based Bonus (PBB) for Fiscal Year 2022 under Executive Order No. 80, s. 2012 and Executive Order No. 201, s. 2016". The guideline aims to measure and evaluate the performance of agencies with emphasis on the public's satisfaction on the realization of the agencies' performance targets, quality of service delivery, efficiency in the use of resources and strengthened agency stewardship.
