APPROVING THE OFFERING OF THE BACHELOR OF ARTS IN LITERATURE, FURTHER DETAILS OF WHICH ARE REFLECTED IN THE DOCUMENT HERETO ATTACHED AND MADE PART HEREOF.

WHEREAS, by virtue of R.A. 9437 the Visayas State University (VSU) is mandated by law to offer undergraduate, graduate and non-degree courses within its areas of specialization to meet the demands of the province and the region;

WHEREAS, Section 13 of RA 7722 "the higher education institution shall exercise academic freedom in its curricular offerings but must comply with the minimum requirements for specific academic programs, the general education distribution requirements and the specific professional courses";

WHEREAS, the CHED Memorandum Order 21, s. 2017, Policies, Standards, and Guidelines for the Bachelor of Arts in Literature/Bachelor of Arts in Literary and Cultural Studies implements the "shift to learning competency-based standards/ outcome-based education", specifies the core competencies expected in the program;

WHEREAS, the Department of Arts, Languages, and Literature (DALL) proposed to offer Bachelor of Arts in Literature (Literary and Cultural Studies Track) that will expand and diversify the curricular offerings of the university to include the liberal arts as an important field of knowledge;

WHEREAS, the University Academic Council endorsed approval of the proposed curricular offering of the Bachelors of Arts in Literature (Literary and Cultural Studies Track) at Visayas State University on February 2, 2024;

WHEREAS, Section 4 (i) of R.A. 8292 specifically empowers the Board of Regents of the University to "approve the curricula, institutional programs and rules of discipline drawn by the administrative and academic councils";

RESOLVED, AS IT IS HEREBY RESOLVED, that the Board of Regents of Visayas State University approve the proposed offering of the Bachelor of Arts in Literature, further details of which are reflected in the document hereto attached and made part hereof.
