Compliance of All COA Notice of Suspension

In view of the Notice of Suspensions (NS) issued by our COA Audit Team last October 2021 related to food expenses incurred last calendar year 2020, please be reminded that you are all required to comply with the needed supporting documents as indicated in the attachment of your Notice of Suspensions. Kindly coordinate with the assigned personnel in the Accounting Office as per OP Memorandum Circular No. 574 dated August 24, 2020. (refer to Attachment A)

As a partial result, we have attached offices who needs to communicate with Accounting Office since they have not yet received any feedback from them. (Attachment B)

Further, please be reminded that failure to submit the required documents after ninety days (90) of receipt of NS will automatically turned into a Notice of Disallowance. This would mean full payment/refund of the amount indicated in the NS.

To avoid this scenario, we would ask for the full cooperation of each offices issued with Notice of Suspension. The deadline of the submission of documents to the Accounting Office is not later than January 27, 2022 (Thursday) to give enough time for review of documents since the 90-day period will lapse by end of February 2022.

re: Food Expenses

The COA Audit Team has issued Audit Observation Memorandum (AOM) No. 2021-010 dated April 29, 2021, pertaining to the disbursement of food expenses. The same audit finding was also included in the 2020 Annual Audit Report.

We have already complied with the requirements on selected transactions as indicated in the Audit Report. However, the auditor's rejoinder requires us to submit the lacking supporting documents of all vouchers on food expenses across different activities (meetings, field activities, planning, etc). Furthermore, COA will issue a Notice of Suspension anytime this month.

As an advance corrective action of the management, different offices mentioned in Table 2 are directed to promptly submit the required lacking documents. Failure to comply will lead to the issuance of Notice of Disallowance which will result in the refund of the amount obligated for food.
