2. To recommend to the President actions on proposals on new curricular programs or revisions of existing graduate and undergraduate curricular programs of the academic units of the main campus before these are endorsed to the Academic Council and other approving bodies for appropriate action;
3. To perform other functions that may be assigned by the Vice President for Instruction/or the President.
