R E: Reconstitution of the VSU Energy Efficiency and Conservation Committee

With Dr. Edgardo E. Tulin as Chairperson, Mr. Toni Marc Dargantes as Vice Chairperson and the rest as members, the VSU Energy Efficiency and Conservation Committee is hereby reconstituted effective immediately until December 31, 2023. The functions of this committee are the following:

- 1. Formulates Energy Conservation Plan/Programs of VSU;
- Identifies the different areas for energy conservation and recommend to the President, plans and practical measures to attain at least 10% energy savings of the University, without sacrificing the mandate of the University as an instruction and research institution:
- 3. Monitors the progress of the energy conservation plans of the University, in accordance to the recommended measures of Rule 3 Sections 3 and 4 of the IRR Directing the Institutionalization of a Government Energy Management Program (GEMP);
- 4. Coordinates with other agencies with regards to energy conservation measures of the University; and
- 5. Evaluates and endorse research, infrastructure and capital outlay proposals related to energy conservation to OVPREI and to OVPPRGAS, respectively.
