Request of Ms. Anely D. Vibas (BSDC II Student of ViSCA) to deny/refuse entry of his Father, Mr. Alfonso Vibas, to ViSCA premises

Sir:

Ms. Anely D. Vibas' request to bar the entry of his father, Mr. Alfonso Vibas, maybe granted on the following considerations:

Firstly,

Ms. Vibas institution of a criminal complaint with the Fiscal's Office against his father for acts of lasciviousness only indicates her firm conviction of pursuing his father criminally as vindication of his father's bestial attempt to sexually abuse her own child. As a consequence thereof, an atmosphere of strained relations now pervaded in their family. In fact, as intimated, her mother, her relatives and herself are bent on pursuing the case and even closed the door for reconciliation. His father is now seeking forgiveness in an effort to withdraw the criminal suit filed against him. Considering the gravity of the offense/charge, her father would do everything on his power to desperately prevent criminal prosecution. Her father's actuation is therefore threatening and intimidating to Ms. Vibas' security and safety. Such imminent and potential danger therefore exist to the life and limb of Ms. Vibas. Since she is our student and living within our jurisdiction, the College is under obligation to keep her safe and protect her from external danger.

Secondly,

as an institution of learning, of utmost thrust concerns the safety and security of our students. It would be unthinkable that a student under our cradle will feel disturbed and worry about her safety and at the same time tackle the rigors of academic competition. Instinctively, she would first look after her safety. It will be saddening if students' academic performance will be prejudiced just because of an unsafe academic atmosphere. We can't afford this to happen. It is therefore incumbent upon the College to continually ensure the safety and protection of its constituents.

Lastly, in the greater interest of welfare, safety and peace of mind, Ms. Anely D. Vibas deserves the assistance she needs.

Therefore, ViSCA, in the exercise of its police authority, has the power to regulate the ingress and egress of the campus as well as discriminate entry of visitors thereto.

Or, in the alternative, Mr. Alfonso Vibas may be allowed to see and/or visit his daughter provided he must be closely monitored and if possible, escorted to and from her daughter's dormitory, if only to give due regard to his parental right over her daughter. Though we cannot deprive him of his parental authority over her child, the law entertain exceptions to this. His attempt to violate the dignity of her daughter forfeits such authority/right over her child and can therefore be denied access to his own daughter.
