R E: Discrepancy of Tax Identification Number

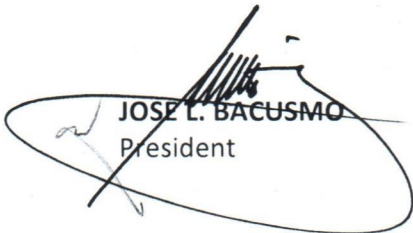
