1.0 Purpose of the Circular halom all all constants de additions

The Circular dated 17 December 1999 was issued to provide guidelines on the implementation of Administrative Order No. 100 entitled, "Directing the Suspension of the Hiring of New Personnel for Purposes of Generating the Additional Funds for the Implementation of the 10% Across-the-Board Salary Increase for FY 2000", dated 01 December 1999.

2.0 Coverage, Prohibition and Exemptions

2.1 Coverage - These guidelines shall apply to all positions in all departments and agencies of the Executive Branch including government-owned and/or -controlled corporations and state universities and colleges.

- 2.2 General Pronibition The hiring of new personnel whether on a permanent, temporary, substitute, co-terminus, contractual or casual status, is hereby suspended. Hiring of new personnel refers to the first-time entry of personnel in the career and non-career service involving the issuance of an original appointment/contract, or reemployment.
- 2.3 Exemptions The following positions may be filled through the hiring of new personnel:
 - Positions in agencies with fiscal autonomy as provided for by law (CSC, COA, COMELEC, CHR, and Ombudsman);

- Key positions (From Secretary to Head of Division Level-Organizational units);
- Teaching positions in schools and educational institutions (DECS-operated schools and DOST-supervised Philippine Science High Schools);
