This office received Notices of Settlement of Suspension, Disallowances, and Charges (NSSDC No. 24-020 to 24-023) indicating the following:

- a) Partial settlement of the lacking DVs and their supporting documents amounting to Php 164,525.44, leaving a balance of Php 53,442.50 (NSDDC No. 24-020)
- b) Full settlement of the lacking DVs and their supporting documents amounting to Php 1,479,760.16 (NSDDC No. 24-021)
- c) Partial settlement of the lacking DVs and their supporting documents amounting to Php 92,224.17, leaving a balance of Php 197,015.08 (NSDDC No. 24-022)




