REFERENDUM NO. <u>07</u> Series of 2024

CONFIRMING THAT THE VSU MAIN CAMPUS HAS BEEN OFFERING THE BACHELOR OF SCIENCE IN MECHANICAL ENGINEERING PROGRAM SINCE AY 2011-2012 UNTIL THE PRESENT

WHEREAS, by virtue of R.A. 9437 the Visayas State University (VSU) is mandated by law to offer undergraduate, graduate and non-degree courses within its areas of specialization to meet the demands of the province and the region;

WHEREAS, Section 13 of RA 7722 "the higher education institution shall exercise academic freedom in its curricular offerings but must comply with the minimum requirements for specific academic programs, the general education distribution requirements and the specific professional courses";

WHEREAS, through the strength of BOR Resolution No. 45, s. 2010 approving the Policy Guidelines on the Adoption of existing Academic Degree Programs within the VSU System, the Bachelor of Science in Mechanical Engineering Program was first offered in the VSU Main Campus in AY 2011-2012, adopting the BSME curriculum from VSU Isabel:

WHEREAS, stipulated in the approved policy that in the adoption of a particular curriculum within the VSU system, provided that no changes are made, BOR approval is not required;

WHEREAS, underscored in the summary of findings/deficiencies during the COPC evaluation in August 2024 is the lack of BOR approval to adopt the BSME Program in Isabel Campus and offer the same program in the Main Campus;

WHEREAS, to comply with the deficiency, the College of Engineering and Technology requested for BOR confirmation and/or acknowledgement of the BSME program offered in the Main Campus;

WHEREAS, Section 4 (i) of R.A. 8292 specifically empowers the Board of Regents of the University to "approve the curricula, institutional programs and rules of discipline drawn by the administrative and academic councils";

WHEREAS, the University Academic Council favorably endorsed the proposal to the Governing Board via referendum.





Now, therefore, on motion, duly seconded, and unanimously approved, be it;

Resolved, as it is hereby resolved, that the Board of Regents of Visayas State University confirmed that the VSU Main Campus has been offering the Bachelor of Science in Mechanical Engineering program since AY 2011-2012 until the present.
