Mr. President,

Pursuant to BOR Resolution No. 17, s. 2016 dated 29 March 2016, the Governing Board UNANIMOUSLY approved the Recommendations of the BOR Investigation Committee, to wit:


1. *that*, the incumbent USSC should man-up and take responsibility for the payment of the outstanding loan borrowed from the ViFARD *care of* former VSU President Dr. Jose L. Bacusmo;
2. *that*, the incumbent USSC officers should immediately contact Dr. Jose L. Bacusmo and agree on the process by which the USSC will extinguish its existing P200,000.00 loan obligation;
3. *that*, the other losses incurred as a consequence of legitimate student activities should be charged to the Student Development Funds of the University;
4. *that*, all future student-related trainings and activities duly approved by authorities should be charged against the Student Development Fund following the Guidelines set by the CHED Memorandum Order No. 20, s. 2011;
5. *that*, the remaining affected USSC officers graduating in SY 2015-2016 be allowed to graduate without any lien on their Academic Credentials; and *finally*
6. *that*, the Academic Credentials – Transcript of Records and Diplomas – of all other affected USSC officers be immediately released without any preconditions.

In view of foregoing, it is now imperative that the University release any and all documents which have been withheld from the affected students who have graduated in SY 2014-2015 as well as those who are still to graduate.

This Office is humbly requesting that a written order from the Office of the University President be issued and directed to the University Student Services Office (USSO) and the Office of the University Registrar (OUR) to the effect that the Final Clearances and Academic Credentials (*whenever requested*) be immediately released.
