Dear *Prof. Acedo*,

This is in connection with your letter dated August 17, 2005 informing this office of the possibility of an amicable settlement of the civil case and subsequently the withdrawal of the administrative complaint you filed against Dr. Nestor Pido based on certain conditionalities.

Hereunder are my decisions on the administrative aspect as contained in your aforementioned letter:

1. Your work place shall be separated at least temporarily. Prof. Algerico Mariscal is hereby requested to effect the separation within one month upon receipt of the memorandum.
2. The Memorandum Receipts (MR) of the equipment purchased for Study 1 of the DA-BAR project shall be transferred to you but should be made available for use by other researchers including Dr. Pido. Mrs. Jeanette Israel is tasked to effect the transfer of these MRs within one month.
3. The remaining supplies, materials and chemicals purchased for Study 1 shall be turned over to you within one month. An inventory of the supplies, materials and chemicals turned over shall be prepared and receipted by you. Said items shall, however, be made available for use by other researchers and Dr. Pido through an approved Requisition and Issue Slip (RIS) duly signed by the Director of Philrootcrops. The study or the purpose for use of such items shall be recorded and the quantity used by the requesting parties shall be deducted from the quantity under your custody. Ms. Luzviminda Ternura shall assist you in maintaining a record of the items under your custody. A year-end report shall be submitted to the Office of the President as to the output with regard to the use of such supplies, materials and chemicals from all users

With my approval of your requests, I hope this case between you and Dr. Pido will finally be put to rest.
