We, the undersigned Research Assistants of the ACIAR funded project "LEYTE LIVESTOCK IMPROVEMENT PROGRAM", are filing an administrative complaint against Dr. Alberto A. Taveros, Associate Professor of the College of Veterinary Medicine and Program Leader of the ACIAR Funded "LEYTE LIVESTOCK IMPROVEMENT PROGRAM" for Dishonesty and Falsification of Official Document in violation of Civil Service Law and Rules and the ViSCA Code committed as follows, to wit:

- 1. Dr. Alberto A. Taveros tampered by padding entries and reflecting spurious amounts in an official receipt by including the "ghost purchase" of one piece gas tank (motorcycle) worth Four Thousand Pesos (P4,000.00); and
- 2. By using said tampered official receipt, by submitting it as part of the liquidation of his cash advance.

A certified photocopy from the original of the tampered document is hereto attached as Annex "A".

We hereby state that we have not filed similar action or complaint against the respondent for the same act in any other office, tribunal or agency, except in the office of the President of Leyte State University, ViSCA, Baybay, Leyte, Philippines.
