I wish to report to your office, the violations committed by SG Restor, BL.

It is very sad to know that he arrived Admin bldg at around 2200H and left at exactly 0525H of September 27, 2001. I doubt if he was able to inspect/check the different buildings found at his area of responsibility (AOR).
