APPROVING THE REVISION OF THE UNIVERSITY AND CAMPUS ORGANIZATIONAL STRUCTURES

WHEREAS, VSU is committed to providing quality and excellent service to its most valuable clients, the students and other stakeholders, and to ensuring that the results and outcomes of the various programs, projects, and activities of the university will lead to the attainment of its vision and mission;

WHEREAS, the University adopts an organizational structure that provides the foundation for a more functional, streamlined, relevant, responsive, student-focused operational set-up responsive to the challenges and opportunities of the global academic landscape;

WHEREAS, to carry out the purposes and intent of the Department of Budget and Management NBC No. 589, series of 2022, known as the Revised Organization Staffing Standards for SUCs (Phase I) and the Commission on Higher Education Memorandum Order No. 15, s. 2019, known as the Policies, Standards, and Guidelines for Graduate Programs, and to create a comprehensive approach that addresses both the physical and cultural dimensions of students and communities, revisions of the university and campus organization structures are proposed;

WHEREAS, the proposal was presented at the meetings of the University Academic Council and University Administrative Council on September 11, 2024 and September 12, 2024, respectively, and which obtained favorable action;

WHEREAS, the Board, during its meeting on October 15, 2024, suggested to the University President to conduct a consultative meeting and re-submit the proposal to the Board via referendum;

WHEREAS, the proposed changes in the university and campus organizational structures were presented to the respective campus' stakeholders, faculty, and staff for critiquing and consideration;


WHEREAS, a university-wide meeting was held on November 6, 2024 to ensure that the revisions of the organizational structures were made known to all sectors in the university;

Now, therefore, on motion duly made, seconded, and unanimously carried, be it:

RESOLVED, as it is hereby resolved that the Governing Board of Visayas State University approves the revision of the university and campus organizational structures.



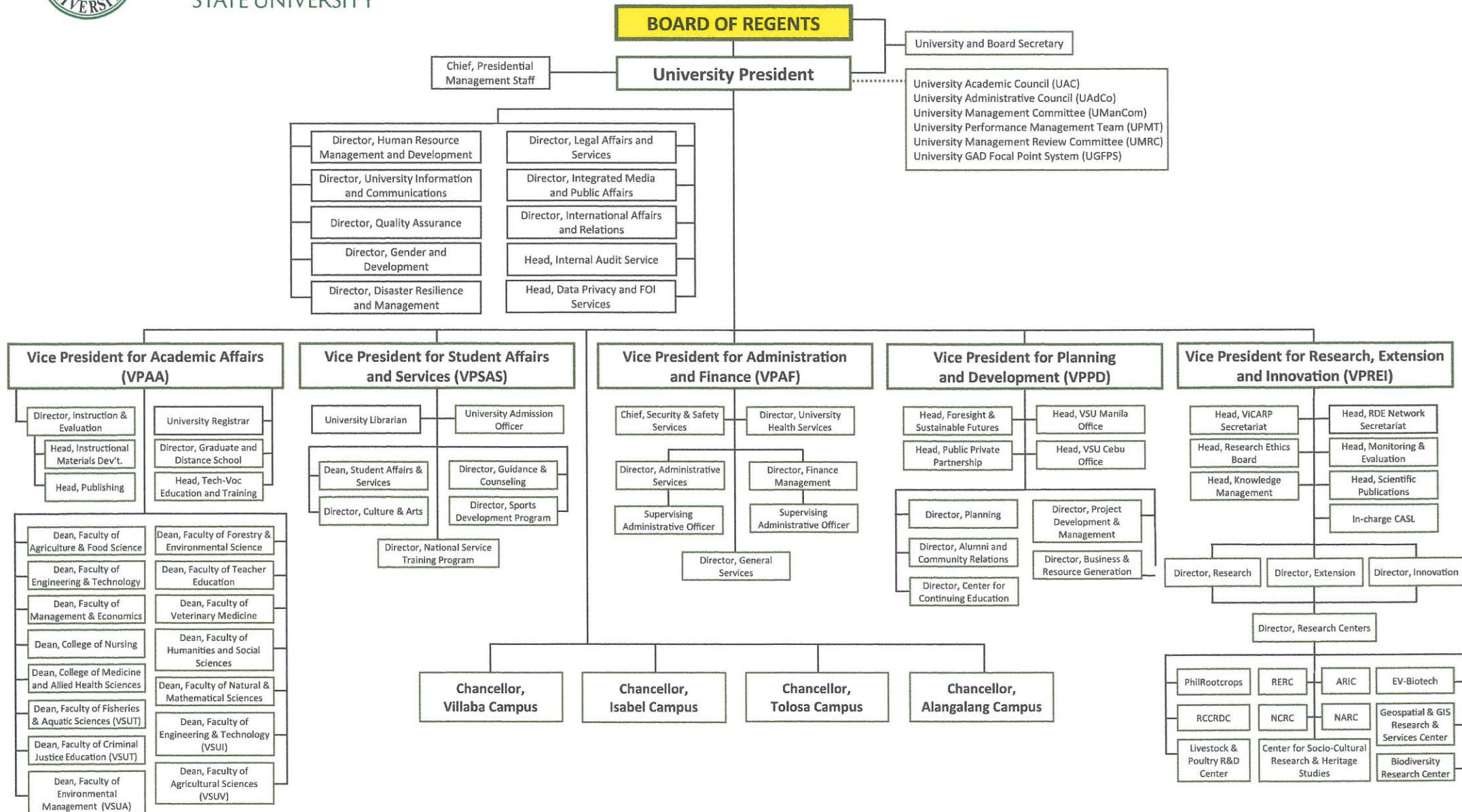

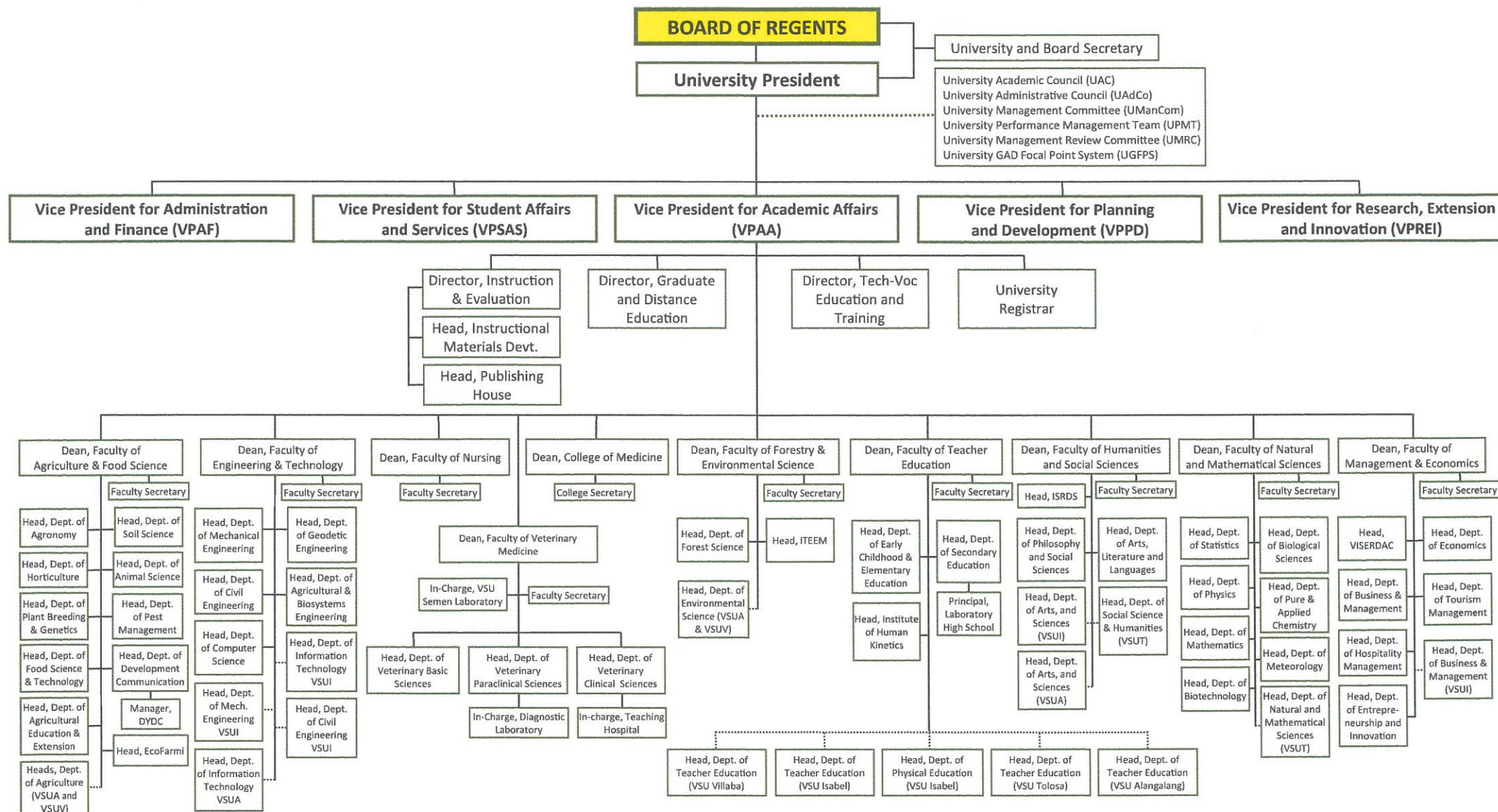
ORGANIZATIONAL STRUCTURE

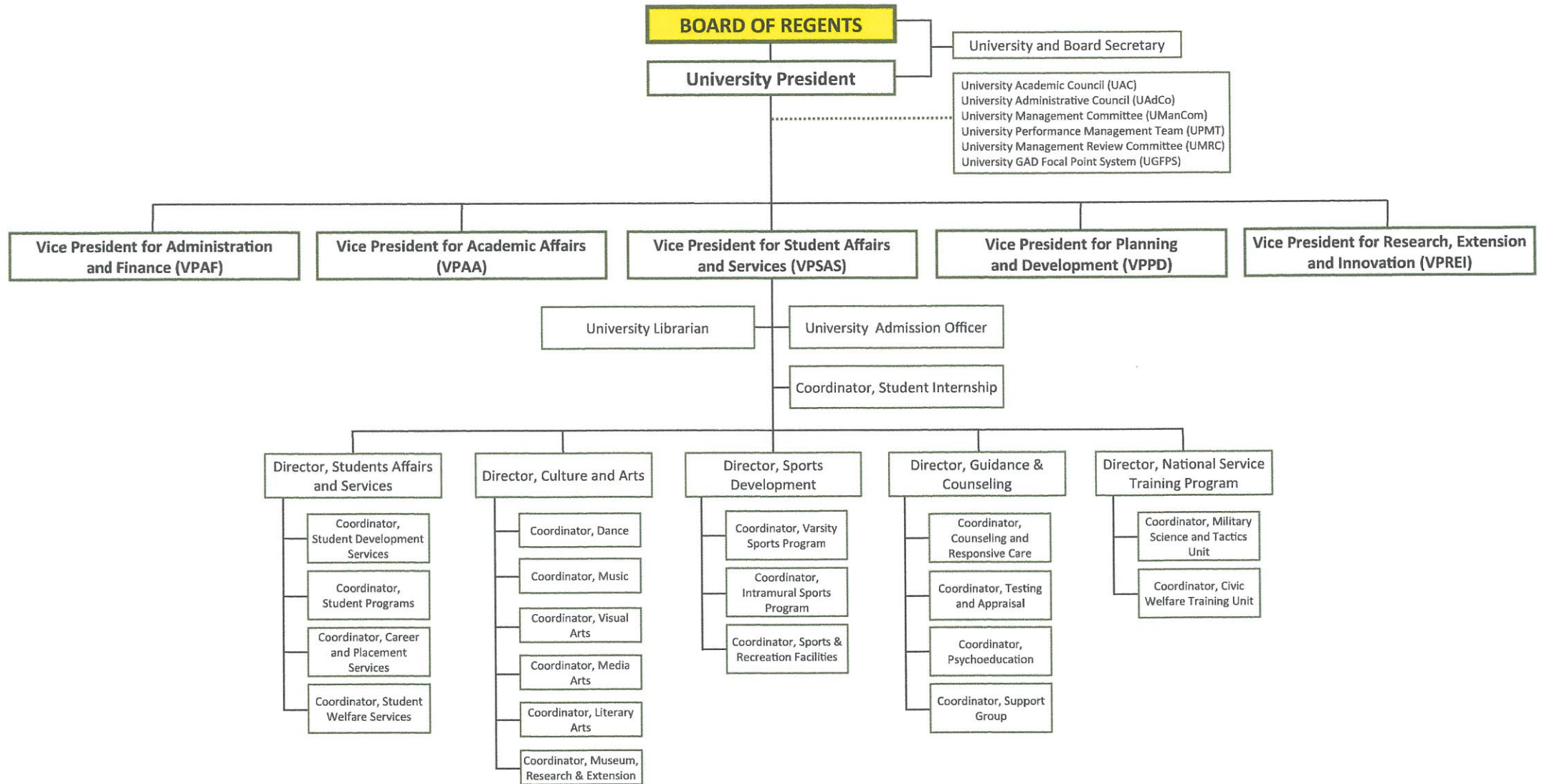
ORGANIZATIONAL STRUCTURE (OVPA)

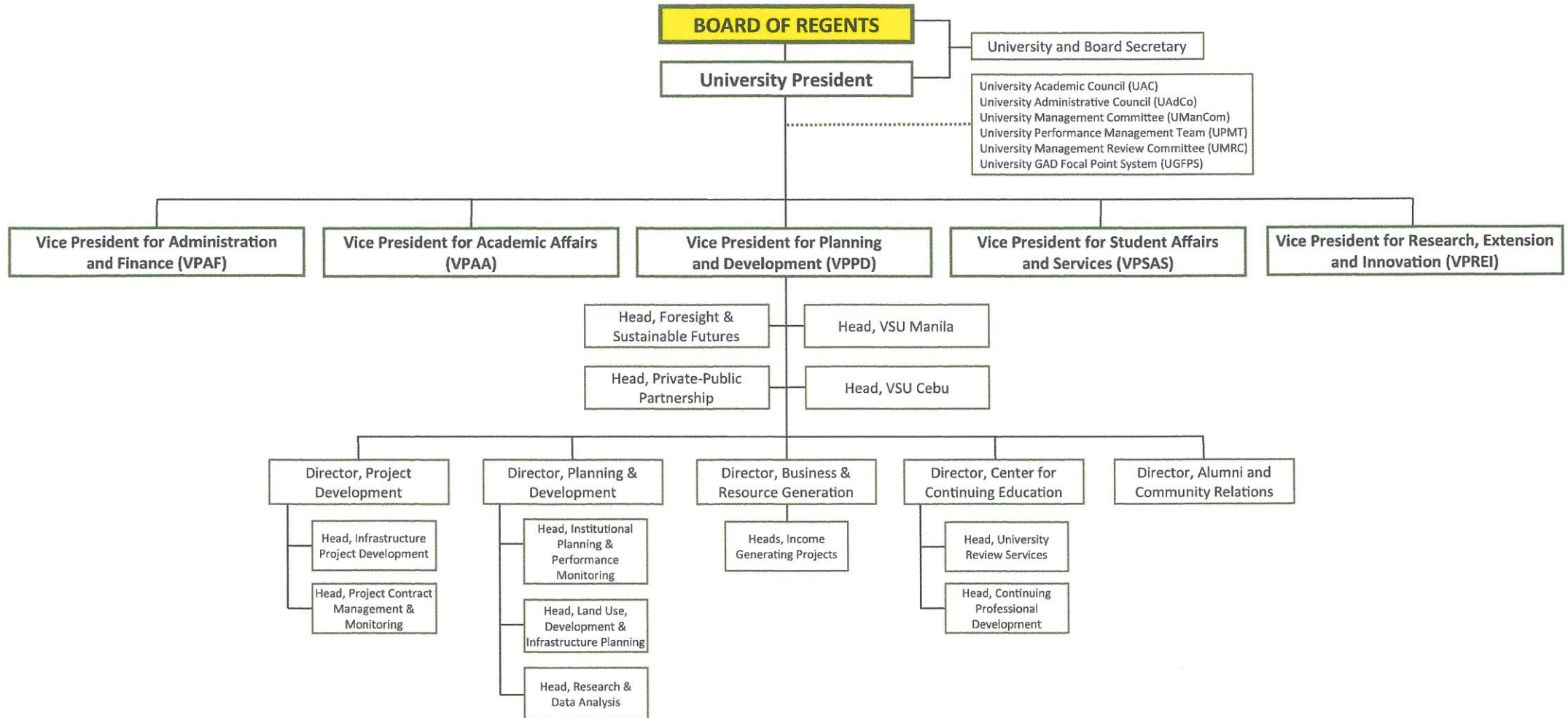
ORGANIZATIONAL STRUCTURE (OVPSAS)

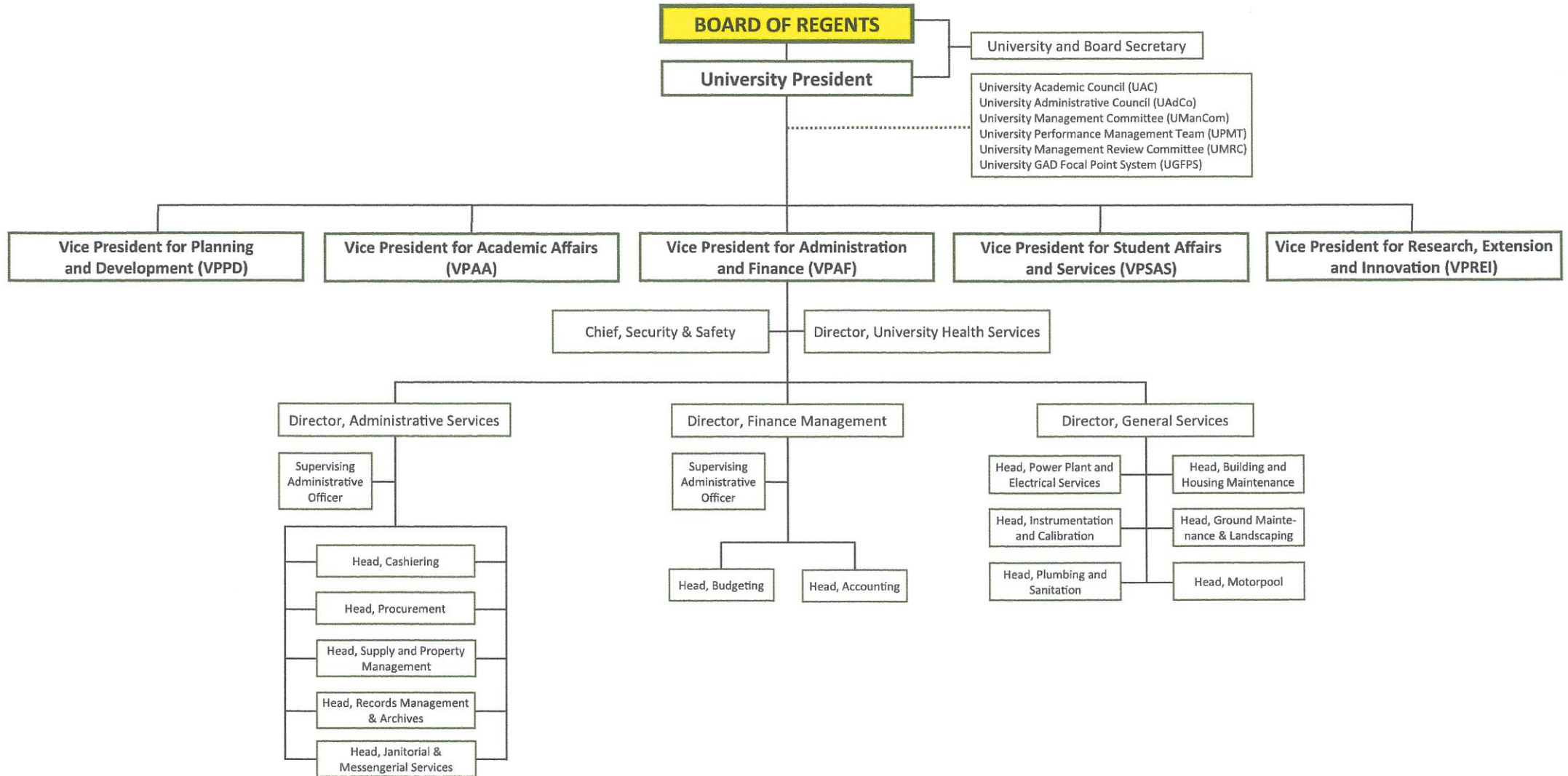
ORGANIZATIONAL STRUCTURE (OVPPD)

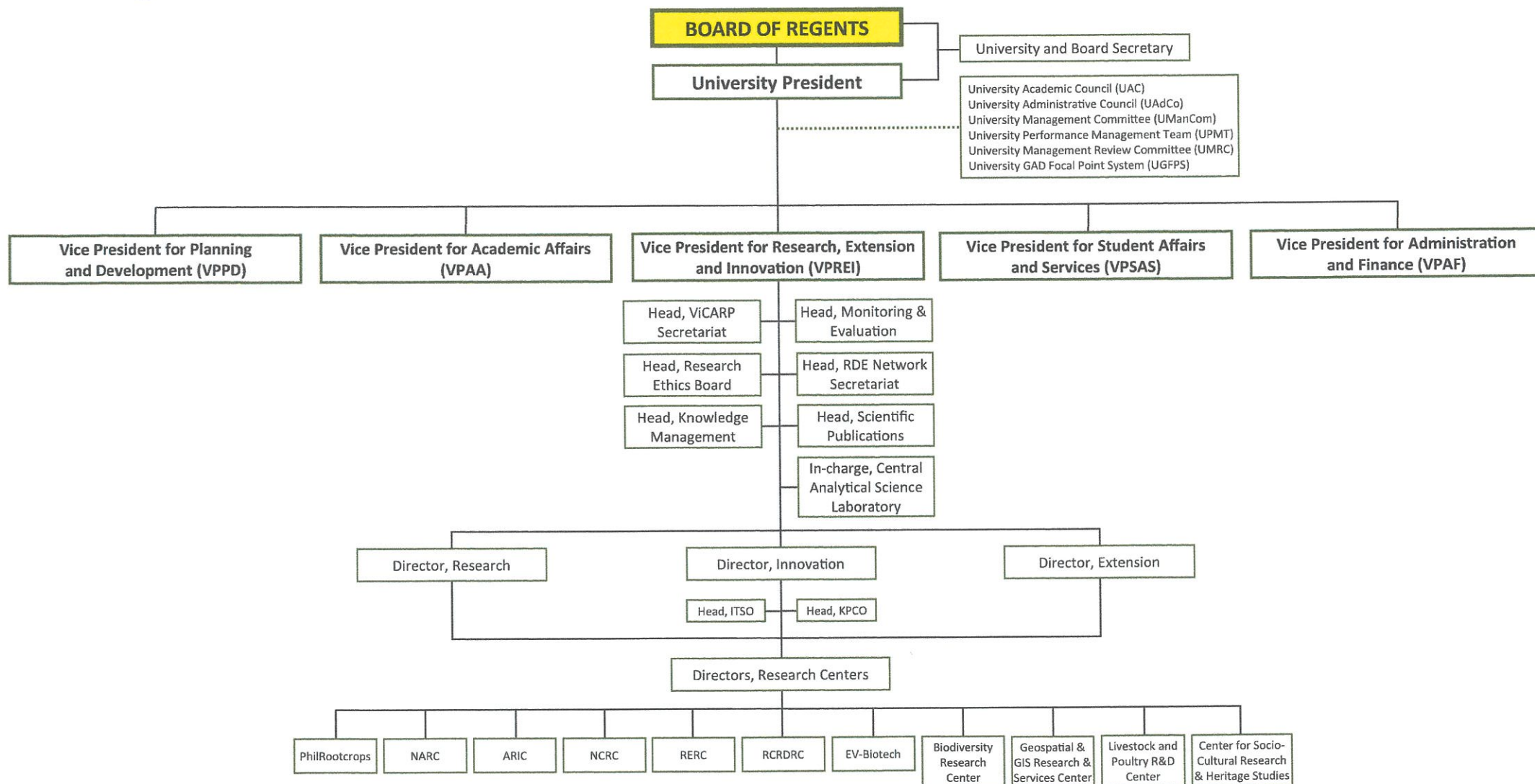
ORGANIZATIONAL STRUCTURE (OVPAF)



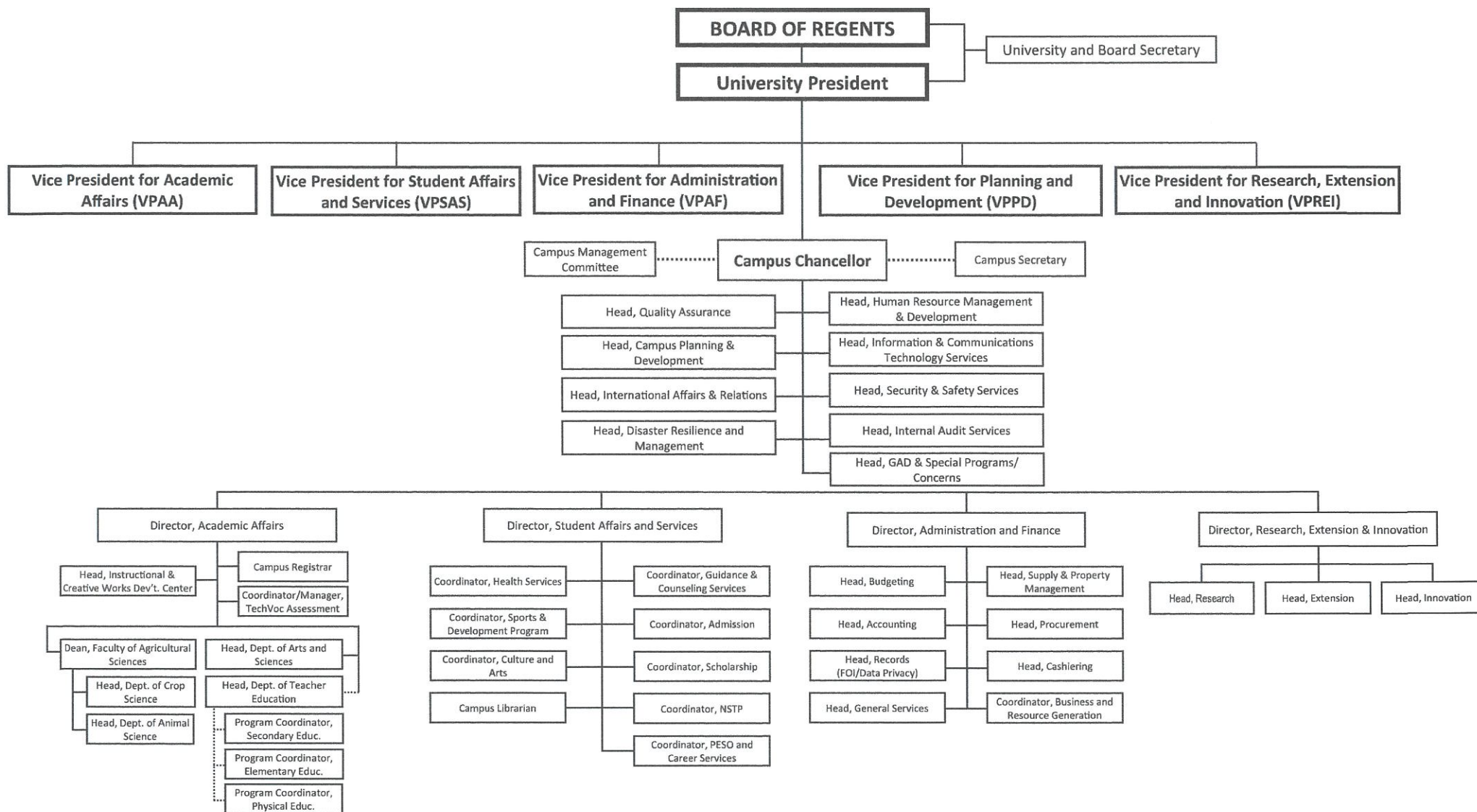

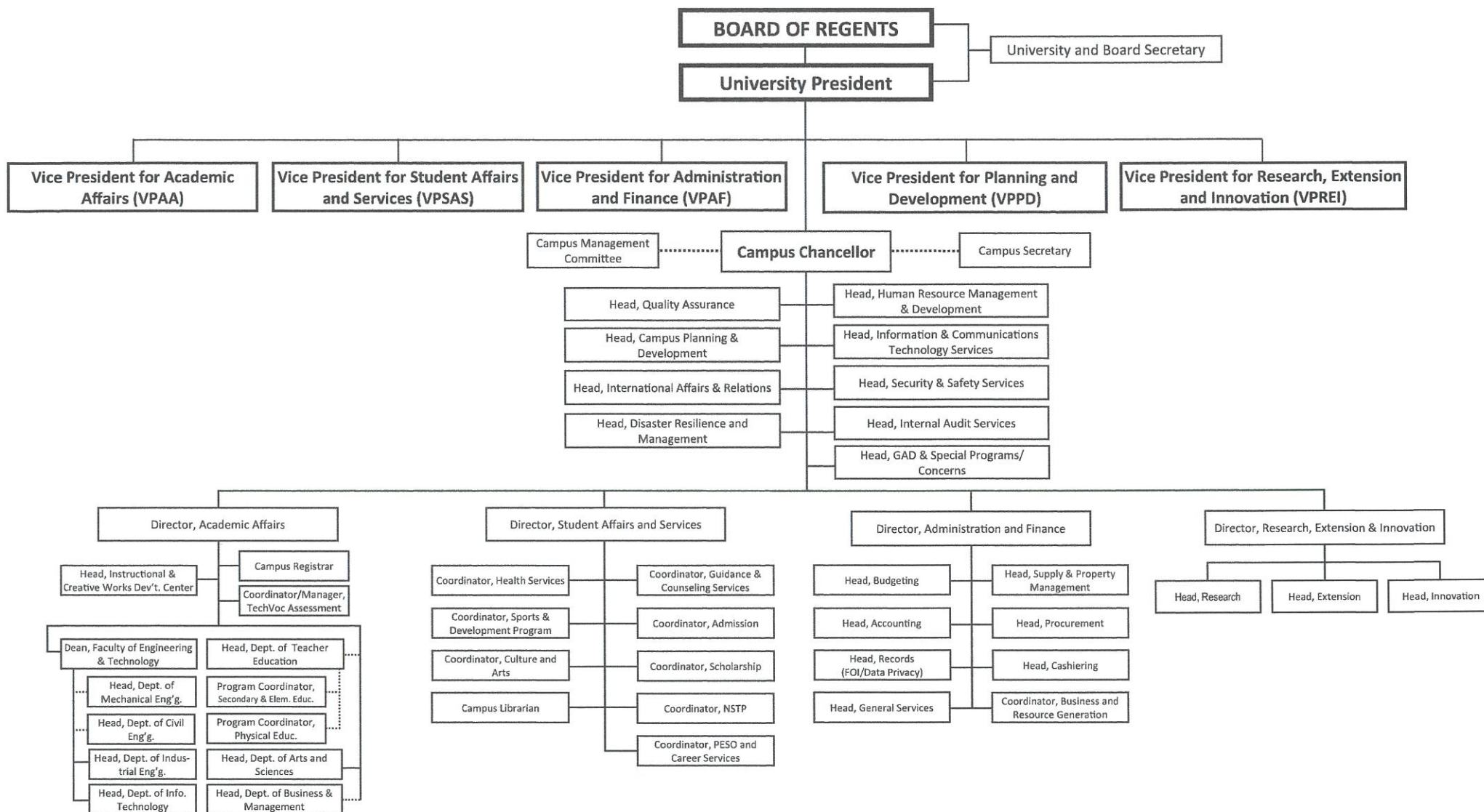
ORGANIZATIONAL STRUCTURE (OVPREI)



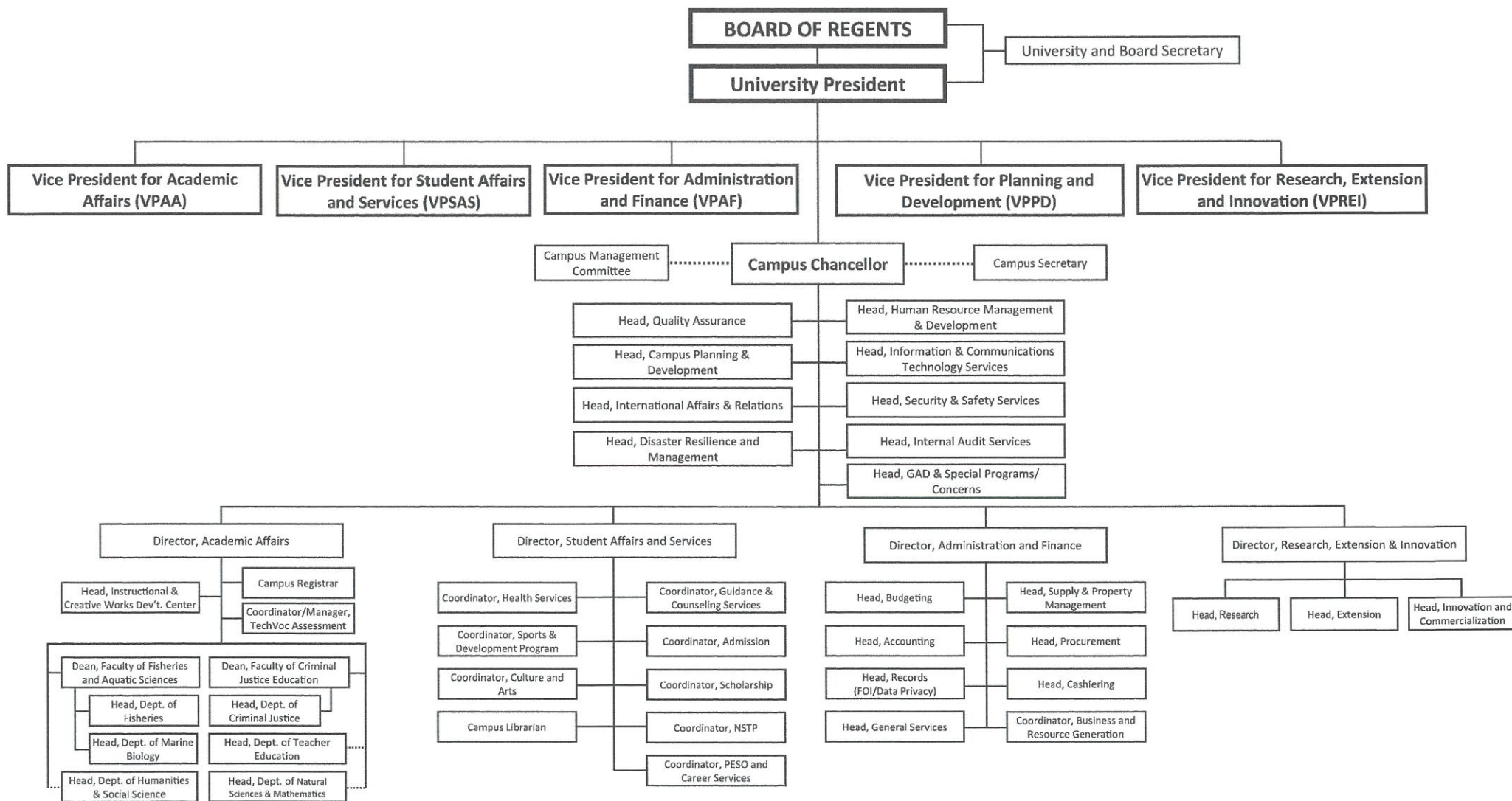
ORGANIZATIONAL STRUCTURE (VILLABA)
