SUBJECT: SECURITY GUARD REPORTED SHOWING DISRESPECT AND INSUBORDINATION

Sir:

I would like to report to your good office that at around 0655H in the morning of 14July2019 while I was at the Security Office Conference Hall I asked SGI Caintic HS why is it that he is always late in reporting for duty even though his house is just in Brgy Guadalupe while I am living at Brgy Sabang and arrived early in reporting for duty.

He got angry and said, "Ngano ako ra man imo bantayan, Boy?" I told him it is my duty as supervisor of the group to monitor all the members. "Kay ngano man diay ug supervisor ka mahadlok ko nimo? Sige ireport ko. Imo naman gani ko gireport kaduha. Dili ko mahadlok nimo."

To avoid more arguments I just went out and proceed to Post # 01.

Minutes later, we heard a loud bang like slamming a door. After that, SG Caintic passed by and shouted at me and challenged me to a fistfight which was witnessed by SGI Pasilaban NA, SGI Tan Be Jr and Wm Serviño NM. Dr Mangaoang also heard the shouting which stopped beside the fence of the wild pigs and deer.

When he arrived at the admin building where he was assigned at the front door he called me thru handheld radio and again challenged me to a fistfight saying, "Dili ko mahadlok nimo Boy bisan ug supervisor ka."

I advised him not to use the radio because there are many individuals with handheld radios who are monitoring us. Still he was saying bad words against me.

When SGI Tan BE Jr called him by radio and told him not to use it he stopped.

It was a big insult on my part as supervisor guard when SGI Caintic showed disrespect, and acts of insubordination on his superior.

May I recommend that SGI Caintic be suspended or advised to retire to avoid future conflict against other supervising guard and co-guards. He committed many violations already like, sleeping on post while on duty, late in reporting, abandonment of post without proper information, showing disrespect to supervising guards and others.
