1:00 pm	-	5:00 pm	Special Protection of Children Against Abuse, Exploitation and Discrimination

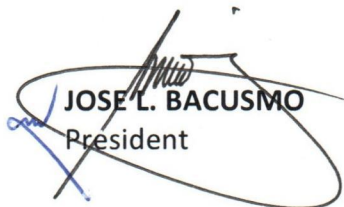
Day 2 (24 Nov.)
