- Review and evaluate the gravity of each risk by considering its consequences in their assigned offices.
- 3. In their assigned offices, identify potential risk exposures, recommend solutions, implement approved programs, promote loss prevention, and update and monitor compliance of government statutory and regulatory provisions.
- 4. Develop risk management controls and systems and design processes to eliminate or mitigate potential risks in their respective offices.
- 5. Prepare reports and present recommendations to the University Risk Manager.
- 6. Do other tasks related to risk management in their assigned offices.

Moreover, they are entitled to the privileges granted and the responsibilities attached to the position subject to pertinent policies.
