
SUBJECT: Penalty for Violation of Student Code of Discipline

This is to forward to your office the report of Mr. Ludito Ramirez, adviser of Mahogany Men's Hall. After the investigation and study of the case the Student Disciplinary Tribunal (SDT) recommends the following:

1. For Mr. Bo Brian Abejuela - Guilty of violation of curfew hours and for illegal entry in dormitory as stated in Disciplinary Action Article VII Section 6 e and f.

Recommendation: Penalty of 40 hours hard labor.

2. For Robert Cafe, Gary Gaviola, Eliseo Libre, Cesar Limbaga and Anthony Madayag - Guilty of violation of curfew hours, illegal entry in the dormitory and drunkenness as stated in Disciplinary Action, Article VII, Section 2.a and in Section 6 e and f.

Recommendation: Offenses punishable of 440 hours of hard labor.

3. For Michael Basilisco and Eugene Daylusan - Guilty of violation of curfew hours, illegal entry in the dormitory, drunkenness and bottle smashing as stated in Disciplinary Action, Article VII, Section 2, a, Section 3, f, and Section 6, e and f.

Recommendation: Offenses punishable of 704 hours of hard labor.

And recommends further that a certificate of accomplishment be a prerequisite for the first semester final examination clearance.
