The meeting was called by the Finance Committee Chairman. Dr. Nerelito P. Pascual to discuss the 1995 allocation of funds. Before the meeting started, Ms. Milagrosa L. Camotin was designated as committee secretary. Ms. Norma V. Cala distributed the copies and explained the figures reflected in the report as follows:

- 1. The amount appropriated for the year 1995 was based on last year's appropriation except for repairs and maintenance of government facilities (04) and of motor vehicles (05). The reserve of five per cent (5%) for the maintenance and other operating expenses (MOOE) can be taken from capital cutlay funds so as not to reduce the funds alletted for MOOE. For labor contracts, thirty per cent (30%) of the alletted funds for repairs and maintenance can be distributed to the different units. The Contralized Fund - Administration under (04) is enother funding source for leber copleyments
- 2. Twenty-five per cent (25%) of the allotted funds for supplies and materials (07) can be utilized for emergency purchases and the remaining emount should pass through the centralized procurement.
- 3. The allotted funds for water, illumination and power services (14) are for VCO, VMO and Administration. All donations realized from electric consumption are remitted to trust fund. Questions were relied on ATI and ATEAP billing for electricity communition. The Administrative Officer suggested that an electric mater should be installed at ATI to account for the actual electric communition and informed PFO regarding this move.
- 4. The allotted funds for other services (29) includes printing services for materials relegand by PICRO and the armual reports of Plenning Davelopment Office.
