MEMORANDUM CIRCULAR NO. 148

- R E: Call for Participants for the Training on Climate Change Expenditure Tagging (CCET)

The Visayas State University, together with other state universities and colleges (SUCs), government-owned and controlled corporations (GOCCs), and national government agencies (NGAs), is legally mandated to tag climate change-related programs/activities/projects (PAPs) in the budget forms with the climate change typologies following the Joint Memorandum Circular (JMC) 2015-01 issued by the Department of Budget Management (DBM) and Climate Change Commission (CCC), in order for the government to effectively track allocated public funds in efforts to mainstream climate change.

In compliance with the JMC, expertise on Climate Change Expenditure Tagging (CCET), that is the budget tagging of climate change-related expenditures, is needed by researchers and officers involved in the planning and budgeting processes for the University to conform to the standard climate change typologies and Quality Assurance and Review (QAR) process in preparing and submitting documents.

Hence, the Regional Climate Change Research and Development Center (RCCRDC) is organizing a Climate Change Expenditure Tagging training on October 25, 2023 at RCCRDC Training Hall D, VSU, Baybay City, Leyte. In this training program, participants will be oriented on the CCET process in SUCs. The specific goals are the following: 1) Stakeholders become knowledgeable in climate typologies and expenditure tagging; 2) Enhanced tracking of climate change-related public expenditures; and 3) Mainstream climate change into public expenditures.

Expected participants are researchers implementing or planning to conduct climate change-related PAPs and planning and budget officers in VSU. The training is free of charge, but the number of slots is limited to 30 only. We will accommodate 2 participants from each of the external campuses.
