The Annex Building already has the main structure defining the first and second floors. The work of the roofing of the annex building is on-going and scheduled for completion this year.

Most of the building materials for completing the 1st floor are already delivered but need the labor (P540,000.00) and additional materials (P420,820.00) for a total amount of P960,820.00.

The Annex building plan has been made but needs to be updated to include provision for a Smart Classroom of the Graduate School and accommodate the rooms planned on the first and second floors.

Recommendations:

- Approve the request of the Department of Mathematics and Physics to utilize the whole
 of the 1st floor of the annex building.
- 2) While the proposal by Dr. Guarte was already included in the PIPOL System of NEDA for possible funding by DBM, it may take more than two years before starting the completion work if approved. The University may explore another funding source to complete the Annex Building the soonest.

There being no matters discussed, the Chairman adjourned the meeting at 12:45 PM.
