This is to require all Project Leaders with funds listed in the National Expenditure Program 2024 to submit their Project Procurement Management Plan (PPMP) and Purchase Requests (PRs) on or before 15 August 2023. The NEP has been approved by PBBM which will be submitted to Congress as basis of the General Appropriations Act.

The Project Leaders should ensure that a market research is conducted prior to the preparation of the PPMP in order to come up with an updated specification and estimated price per item. Do not depend on the price list in the SPPMIS as most of the prices are as good only of the last bidding date.

The Bids and Awards Committee will hold the Early Procurement Activities for all these projects starting last week of August 2023 and ends on the last week of September 2023. For the information of everyone, the Early Procurement Activity is most desired by DBM and the IATWG of AO 25 and must be implemented for the sake of compliance of the Annual Cashbased Budgeting of 2019. All funds must be consumed/disbursed by late November 2024 with last payment by March 2025.
