President's Notation on the June 18, 2021 minutes "The NAPB Board should double time (speed up) in the hiring of Admin Staff because there are offices that need immediate functions of these positions.

Deliberation:

Basic question raised is the possibility to do double time following the selection process starting from the shortlisting of applicants, interview, skills test then comparative assessment, which will really take time. The NAPB meeting is done only once a week and the Chairman suggested to possibly meet twice a week. The Secretary also raised her concern that transcribing the interviews also cause the delay of the minutes. Ms. Colis suggested that the transcripts of interviews can be submitted separately from the minutes in order to speed up the preparation of the minutes. Dr. Yu even mentioned that in meetings of previous boards where he served as member, only the action of the board was being indicated but the transcripts of interviews were not included. Evaluation of interviews and skills tests were also identified as reasons for the delay, so it was agreed that the members will be given two days after interview and skills test evaluations to submit their assessments.

Therefore, the board agreed that interview transcripts will be submitted later, however the minutes will indicate the name of the applicant including his/her basic information/qualification.

NAPB Action:

Considering the slow turn out of NAPB recommendations for hiring or promotion and the frequency of holding NAPB meetings, the Board agreed to meet twice a week if necessary, with Friday being a compulsory schedule. The interview and skills test evaluations will be submitted to the Secretary two days after being conducted. Transcripts of the interviews of applicants will be submitted later.
