Based on the re-computation of experiences as presented in the above Table, it is still Ms. Galler who ranked first since she is senior in age and had been hired by VSU earlier than Ms. Gonzaga. In addition, both candidates received an Outstanding rating from their supervisors in terms of their potential evaluation. Ms. Gonzaga and Ms. Galler were also recipients of the step increment due to meritorious performance last 2018 and 2019, respectively.

To refresh the Board on the salient provisions on quantum leap in CSC's 2017 ORA-OHRA (Revised 2018), Ms. Colis presented the Sec. 97 and 98 of the said rules, to wit,

"An employee may be promoted to a position which is not more than three (3) salary grade, pay or job grades higher than the employee's present position. All appointments issued in violation of this policy shall be disapproved/invalidated except when promotional appointment falls within the purview of any of the exceptions. The three-salary grade limitation shall apply only to promotion within the agency."

The Board studied and tried to find a possible exception on the said provisions where Ms. Galler can be appointed. However, she falls short on each exception especially on the possession of superior qualifications on education and performance, notwithstanding, that a qualified next in rank applied for the position.

Moreover, Dr. Luzviminda A. Tajos, VSU Isabel Chancellor, was invited during the said meeting to be updated on the situation in the selection of AO I. She relayed that the VSU Isabel Personnel Board and both candidates are well-aware of the provisions on quantum leap in the ORA-OHRA and strongly agreed to comply on the said rules.

After hearing opinions from the NAPB members and Dr. Tajos, the Chair decided to divide the house on who will be recommended for appointment to the AO I position based on the new recomputation. With the present NAPB members, Ms. Ampac voted for Ms. Galler since she knew the excellent work performance of Ms. Galler being the in-charge of Budget job in VSU Isabel. Meanwhile Dr. Yu, Dr. Lambert, Ms. Colis and Ms. Antipaso uphold to their previous decision to appoint Ms. Gonzaga to the AO I position for being the qualified next-in-rank having met qualification standard for the position and that her appointment will not pose an invalidation by CSC as provided for in Sec. 97 and 98 of the CSC's 2017 ORA-OHRA (Revised 2018). Based on the majority rule, it was agreed to recommend approval to appoint Ms. Gonzaga for the AO I position.

The board further requested Dr. Tajos to have a meeting with the top two (2) candidates. As per information from Dr. Tajos, they are just waiting for the approved minutes and NAPB recommendation. Dr. Tajos informed Ms. Colis via phone call that she has already spoken with the two candidates and waiting for the approved minutes.
