Letter of consideration of Mr. Leodel S. Igot regarding his training on Fire and Earthquake drill which he mistakenly submitted the attendance sheet only in the afternoon.

#### **Deliberation**

It was recalled that during the December 3, 2021 NAPB meeting, clarifications on the training points of Mr. Igot was raised by Dr. Yu. The secretary explained to the board that insider applicants were given enough time to submit supporting documents which was set on November 25, 2021 as the deadline. It was agreed then that since the applicant failed to submit supporting documents during the deadlines, both in the publication of the vacancy and Nov. 25, 2021, prior to the final evaluation of credential, submission of additional documents after deadline will not be considered anymore.

To address the current request for consideration of Mr. Igot, concerns were raised on the following grounds: NAPB cannot act on it favorably because it is already beyond deadlines. Moreover, upon review of the document submitted by Mr. Igot, it was found out that his attendance to training on "Fire and Earthquake Drill" which he is claiming for additional points was conducted on Oct. 22, 2021. This was already beyond the deadline of the publication which is Oct. 18, 2021, thus said training cannot be considered for inclusion in the evaluation among Mr. Igot's credentials.
