Attesting the validity of the recommendation of DPM to hire Ms. Roda G. Currently, the university has only implemented inhouse promotion of faculty who have PhD but still occupying instructor positions based on BOR Res No. 135 s. 2022. In-house promotion of lower positions will be implemented university-wide after the implementation of JC3 s. 2023, so that those who applied for reclassification but were not reclassified can also apply.
