Non-Academic Personnel Board Meeting

The update on the approved request of Ms. Erlinda E. Esguerra, Head of Accounting Office, that the regular Adm. Aide III (Utility worker II) position vacated by Ms. Otida which is intended for the senior citizen without eligibility be replaced with casual position per NAPB Res. No. 207 s. 2020, was presented and deliberated.

Deliberation:

The NAPB Secretary mentioned that currently there is no vacant casual Adm. Aide III position as replacement for the regular Adm. Aide III (Utility worker II) position vacated by Ms. Otida, except the 3 casual Adm. Aide III positions for OUDRRM, DPBG and CFES. Meanwhile, she presented the comparative assessment for the Adm. Aide IV (Clerk II) position for Accounting Office for discussion and possible source of candidate to be appointed for the vacated position of Ms. Otida and included the four (4) applicants who submitted online application at the HRIS. The Board reviewed the preliminary assessment on the credentials of the 4 online applicants and the Board found out that even if they will be given the maximum points for the interview and potential, they still lag behind the existing ranking of applicants to the Accounting Office. The Board then agreed that they will not be included as shortlisted applicants for further assessment and interview since they cannot catch up to the points of the 2nd ranked candidate even if they got perfect scores on PCPT and skills, which is predicted not attainable based on previous assessments.

After deliberation, the Board unanimously agreed that Mr. Bartolini, the 2nd ranked candidate and who is a casual Adm. Aide III (Clerk I) assigned at Registrar's Office, be appointed to the regular Adm. Aide III position vacated by Ms. Otida. Mr. Bartolini shall be retained at the Registrar's Office but and that his casual position be assigned at the Accounting Office. The position vacated by Ms. Otida does not require CSSP/CSP eligibility.
