Warm greetings!

The Department of Animal Science under the Faculty of Agriculture and Food Science (DAS–FAFS) respectfully seeks your approval for the hiring of the following teaching personnel for the **First Semester of Academic Year 2025–2026**:

- One (1) Regular Instructor I
- Three (3) Part-Time Faculty Members
- One (1) Adjunct Professor

This request is prompted by several operational and academic needs, as detailed below:

1. Faculty on Study Leave

Three of our current faculty members—Mr. Ronel B. Geromo, Ms. Joycee S. Mandia, and Mr. Jerome O. Arribado (Affiliate Faculty)—will be on official study leave to pursue PhD degrees at the University of the Philippines Los Baños starting AY 2025–2026. Meanwhile, two other faculty members are scheduled to return: Mr. Roger Roque E. Bustamante, who is expected to complete his PhD by July 2025, and Ms. Ma. Rosa De Lima Beato, who will resume limited duties while completing her dissertation.

2. High Student-to-Faculty Ratio and Graduate Program Demands

 Despite implementing a screening process to reduce student intake in the BSA Animal Science program, the Department still faces a high student-to-faculty ratio, ranging from 1:16 to 1:20 in upper-year levels. This affects the quality and timeliness of thesis advising and instruction. Moreover, DAS manages three graduate programs—PhD in Animal Science, MS in Animal Science, and MAgDev—further increasing instructional and advisory responsibilities.

3. Faculty with Administrative, Research, and Extension Appointments

 Several DAS faculty members hold key university appointments that entitle them to reduced teaching loads, in accordance with the faculty manual. Limiting their teaching responsibilities is essential to ensure the effective







performance of their administrative and programmatic functions. The following faculty members hold such positions:

4. Need for Graduate-Level Expertise

The Department also seeks to engage Dr. Oscar B. Posas as an Adjunct Professor to support graduate course instruction and serve as a member of various Graduate Advisory Committees, given his specialized expertise in the field.
