Dear Dr. Tulin:

New Year greetings!

We are again writing to request for the reopening of the two vacant positions for Associate Professors II and III at DAEEx to replace the position of Prof. Fatima Baliña and the position previously opened but was not taken by Dr. Dario Cidro. Instead, we were only given three part-time instructors. In addition, we also request again another three part-time instructors for the second semester SY 2022-2023 since three of our faculty are still on study leave. This is in preparation for the retirement of Dr. Henry Y. Goltiano on March 12, 2023 and Dr. Milagros C. Bales by April 30, 2023. To recall, Ms. Aiza C. Oracion and Mr. Virgelio Dargantes went on study leave starting August 2022. Ms. Oracion requested to extend her study leave until April this year to finish her dissertation requirements for her PhD program. When Dr. Goltiano and Dr. Bales will retire, only three regular faculty will be left behind to handle many graduate, undergrad and services courses in addition to thesis advising. Thus, DAEEx is in dire need for regular faculty positions who can handle the enormous teaching loads and thesis advising. When we open these two positions last year, there were no qualified applicants to the positions. Thus, it is suggested that if there are instructor positions available, we can just groom new MS graduates who can only qualify for Instructor positions rather than wait for qualified applicants to be hired for higher positions which we can hardly find this time.

Please find attached the projected workload for the 2nd semester 2022-2023 and 1st semester 2023-2024 as justification for hiring the said positions.

We hope for the favorable action of this request.
