Dear Dr. Yepes:

Greetings.

The undersigned would like to **request the hiring of additional one (1) regular faculty member** in the Department of Meteorology effective first semester SY 2024-2025 to address the current faculty shortage due to the following reasons:

- 1. The three faculty, namely Mr. Charlindo S. Torrion, Mr. Daniel C. Lor and Engr. Rotsen B. Labisores were not renewed as regular faculty of the department as informed by VSU HRMO in connection with the implementation of CSC Memo Circular No.25, s. 2017 re "Status of Appointment to Faculty Positions in State Universities and Colleges (SUCs) and Local Universities (LUCs) Where There is Dearth of Holders of Master's Degree in Specific Field". However, Mr. Charlindo S. Torrion just finished his MS degree, but his clearance is still in process and has not yet been transmitted to our department from UP Diliman where he just recently graduated. Mr. Daniel C. Lor and Engr. Rotsen B. Labisores are still finishing their MS degree and are scheduled to finish this semester.
- 2. Mr. Charlie S. Andan is on study leave effective 1st Semester AY 2024-2025. He already left to pursue his studies. Engr. Rud Luis G. Gonzaga is set to go out for study leave in the following semester. Their study leave status will make their teaching service put on hold making our workforce insufficient in terms of experience and credentials required for AACCUP and COPC qualifications since the department is scheduled for the Preliminary Surveillance Visit for AACCUP and COPC this semester, where 4 regular faculty members is required in order to qualify for the AACCUP and COPC accreditations.

To effectively address this faculty shortage, the department personnel committee is requesting additional faculty member to join our department. We firmly believe that this would significantly sustain the department's ability to meet its current and future demands for instruction, Research Development and Extension (RDE) and accreditations.

We hope that our request will merit your favorable approval. Thank you for your time and consideration.
