**BOR RESOLUTION NO. 9, s. 2018**

**A RESOLUTION APPROVING THE REQUEST OF THE VSU ISABEL TO UTILIZE  
THE REMAINING BALANCE OF CY 2017 UNAPPROPRIATED COLLECTIONS FROM  
FUND 164 IN THE AMOUNT OF P 469,419.49 FOR AUGMENTATION OF PERSONAL  
SERVICES (PS), MAINTENANCE AND OTHER OPERATING EXPENSES(MOOE) AND  
CAPITAL OUTLAY (CO) *SUBJECT TO EXISTING POLICIES AND GUIDELINES  
GOVERNING THE USE OF SUCH FUNDS***

**WHEREAS**, Republic Act 9158 converted the then Visayas State College of Agriculture (ViSCA) into a state university, the Leyte State University, on 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 7, Paragraph (b) of R.A. 9158 empowers the Governing Board *"to receive and appropriate all sums as may be provided for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University"*;

**WHEREAS**, the VSU Isabel would like to utilize said funds as follows:

A. Augmentation of Personal Services (**P72,000.00**), to wit:

Honoraria – P 72,000.00

B. Augmentation of MOOE Funds (**P 274,956.99**), to wit:

1. Travel Expenses	P 43,847.00
2. Office Supplies	P 2,000.00
3. Other Supplies Expenses	P 8,726.00
4. Other MOOE	P 43,772.99
5. Semi-Expendable ( <i>Sports Equipment</i> )	P 30,000.00
6. Semi-Expendable ( <i>Furniture &amp; Fixtures</i> )	P 22,000.00
7. Printing and Binding Expenses	P 31,025.00
8. Repairs & Maintenance – <i>School Bldgs</i>	P 92,723.00

C. Augmentation of Capital Outlay Funds (**P 122,462.50**), to wit:

1. Furniture & Fixtures	P 45,462.50
2. Information & Tech. Equipment	P 52,000.00
3. Other Machinery & Equipment	P 25,000.00
