#### BOR RESOLUTION NO. 4, s. 2018

A RESOLUTION APPROVING THE PROPOSAL OF THE DEPARTMENT OF FOOD SCIENCE AND TECHNOLOGY (DFST) TO CHARGE A "USERS FEE" FOR THE USE OF THE TWO (2) DTI SHARED-SERVICE FACILITIES (SSF) – THE ROOTCROP PROCESSING AND FOOD TESTING LABORATORY INCLUDING THE DFST FACILITIES AND EQUIPMENT

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

**WHEREAS**. Section 7 of R.A. 8292 empowers the Board to "exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";

WHEREAS, the Department of Food Science and Technology (DFST) was awarded by the Department of Trade and Industry (DTI), Leyte Province, to be the Project Co-Operator of two (2) Shared-Service Facilities (SSF) namely: Rootcrop Processing and Food Testing Laboratory;

**WHEREAS**, the SSF aims to address the gaps and bottlenecks in the Value-Chain of priority industry clusters, by providing processing and/or manufacturing equipment for the common use by MSMEs within the identified industry clusters, as well as provide an integrated package of services including enhanced marketing approaches relevant to the maturity of MSMEs and the target market, and to develop priority and market-driven industries;

WHEREAS, Article III, Section 4 of the MOA between the DTI and VSU with the DFST as the Co-Operator specifies, to wit: "Jointly with the DTI-Leyte, prepare and approve a Manual of Operations which shall include, among others, the 'organizational/functional structure of the shared-service facility; procedure for accessing the services of the facility; business plan, schedule of fees to be collected from the users of the facility; communications plan to promote the use of the facility; and reportorial procedures";

WHEREAS, under Article III, Section 4, Item 1 of the DTI-VSU MOA specifies, to wit: "the Schedule of Fees to be collected from the users of this facility shall take into account the sustainability of the operation of the facility in terms of cost recovery, as well as the building of funds to be devoted solely for the repair and maintenance of the facility including the renewal of an 'all-risk insurance policy' for the facility";

WHEREAS, the DFST conducted a benchmark survey of the rates for the use of equipment and facilities of other academic departments and units of the VSU as well as in other SUCs and government agencies, the DFST was able to come up with the rental rates that will take into account, the sustainability of the operation of the facility in terms of cost recovery, as well as the building of funds to be devoted solely for the repair and maintenance of the facility including the renewal of an 'all-risk insurance policy' for the facility as specified under Article III, Section 4, Item 1 of the DTI-VSU MOA;

WHEREAS, the VSU Board of Regents, on the occasion of its 80<sup>th</sup> BOR Meeting dated 07 December 2017 underscored the "need to come up with a benchmark of renal prices charged by other similar entities with the University as well as in other SUCs and government agencies" before the Governing Board will again tackle the matter in a Regular BOR Meeting;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve proposal of the Department of Food Science and Technology (DFST) for the Use of the Two (2) DTI Shared-Service Facilities (SSF)- the Rootcrop Processing and Food Testing Laboratory Including the DFST Facilities and Equipment, as presented and effective upon Approval by the VSU Board of Regents.
