A RESOLUTION COURSED THROUGH REFERENDUM APPROVING THE REQUEST OF DR. ANABELLA B. TULIN FOR AUTHORITY TO TRAVEL TO GHENT UNIVERSITY, GHENT, BELGIUM FOR THE PERIOD 2 JULY 2019 UNTIL 14 JULY 2019 SUBJECT TO EXISTING RULES AND REGULATIONS GOVERNING FOREIGN TRAVELS BY GOVERNMENT OFFICIALS

**WHEREAS**, the Aquatic Ecology Research Unit of the Ghent University, Ghent, Belgium through the efforts of Prof. dr. ir. Peter Goethals, has tendered an invitation to Dr. Anabella B. Tulin to visit Ghent University from 2 July 2019 to 14 July 2019;

**WHEREAS**, Prof. dr. ir. Peter Goethals expects Dr. Anabella B. Tulin to draft a project proposal for VLIR-UOS funding as well as discuss the content and structure of the proposal;

WHEREAS, the CHED International Affairs Office (IAS) has issued Reference Number 19-6-1662 dated 21 June 2019 pursuant to the Memorandum from the Office-In-Charge dated 24 July 2018 titled: "Guidelines for Securing Authority to Travel Abroad for State Universities and Colleges."19-6-1522;

**WHEREAS**, the Dr. Anabella B. Tulin has accepted the invitation of Prof. dr. ir. Peter Goethals, Aquatic Ecology Research Unit of the University of Ghent, Ghent, Belgium;
