**BOR RESOLUTION NO. 39, s. 2019**

**A RESOLUTION CONFIRMING THE CHANGE IN APPOINTMENT STATUS OF FIVE (5) ACADEMIC STAFF FROM TEMPORARY TO PERMANENT *SUBJECT TO* EXISTING RULES, REGULATIONS AND GUIDELINES GOVERNING SUCH APPOINTMENTS**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 4 of R.A. 9158 specifically provides that the University “*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*”;

**WHEREAS**, among other powers granted to the Board of Regents is the power “*to fix and adjust salaries of faculty members and administrative officials and employees ...*” as stipulated in Section 7, Item (h) of R.A. 9158;

**WHEREAS**, the Academic Personnel Board (APB) of the Visayas State University, undertook a process of screening the most qualifications of the candidates for permanency following the requirements set by the ViSCA Code and in the NBC 461 Guidelines;

**WHEREAS**, after due deliberation, the APB determined that the five (5) faculty members possess the necessary qualifications for permanency, as follows:






