A RESOLUTION APPROVING THE POLICIES AND GUIDELINES CONCERNING STUDENTS FROM FOREIGN ACADEMIC INSTITUTIONS DOING FIELD PRACTICE/ PRACTICUM/RESEARCH AT THE LEYTE STATE UNIVERSITY

WHEREAS, the Leyte State University has been accepting students from foreign institutions undertaking their field practice/practicum/research at the Leyte State University;

WHEREAS, the existing Memoranda of Agreement (MOA) between some foreign academic institutions and the Leyte State University includes exchange of students for the purpose of undertaking research, practicum and field practice;

WHEREAS, the Leyte State University does not have a definite policy covering students of other foreign academic institutions that do not have valid MOAs/MOUs with the LSU for the purpose of undertaking research, practicum and field practice activities;

WHEREAS, there has been a marked increase in the number of foreign students conducting their research, practicum and/or field practice at the Leyte State University;

WHEREAS, the Office of the University President desires to put in place definite policies and guidelines covering foreign students, other than those covered by valid MOAs, interested in pursuing their research, practicum and/or field practice at the Leyte State University;

WHEREAS, the University Administrative Council has gone over the proposed policies and guidelines during its 07 February 2006 meeting and has recommended the proposal to the LSU Board of Regents for final action;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the Policies and Guidelines Concerning Students from Foreign Institutions Doing Research, Practicum, and/or Field Practice at Leyte State University.
