BOR RESOLUTION NO. 20, s. 2014

A RESOLUTION COURSED THROUGH A REFERENDUM CONFIRMING THE TENTATIVE LIST OF CANDIDATES FOR GRADUATION WITH *LATIN* HONORS, VSU SYSTEM, 2nd SEMESTER, SY 2013-2014 *SUBJECT TO* EXISTING RULES AND GUIDELINES ON THE GRANT OF *LATIN* HONORS

WHEREAS, Section 7, Paragraph (j) of R.A. 9158 empowers the Governing Board "to set policies on admission and graduation of students";

WHEREAS, Section 11 of Republic Act No. 9158 – The Academic Council - stipulates the powers of the Academic Council to wit: "... review and recommend curricular offerings and fix the requirements for the admission to the University, as well as for graduation and the conferment of degrees, subject to the approval of the Board...";

WHEREAS, the University Academic Council has reviewed the prospective list of candidates for graduation with *Latin Honors* from the different campuses of the VSU System for the 2nd Semester, SY 2013-2014 on the occasion of its 36th University Academic Council meeting held at the Center for Continuing Education last 11 April 2014; and

WHEREAS, the UAC is strongly endorsing the list of candidates for graduation with Latin Honors from the different campuses of the VSU System to the VSU Board of Regents for Confirmation, Provided, That all the candidates shall have complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2013-2014.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to **Confirm** the prospective list of candidates for graduation with *Latin Honors* from the different campuses of the VSU System for the 2nd Semester, SY 2013-2014 *Provided*, That all the candidates shall have complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2013-2014.
