BOR REFERENDUM NO. 5, s. 2012

A REFERENDUM APPROVING THE PROPOSAL TO GRANT OF *Php*1,000.00 PACKAGE OF GOODIES INTENDED FOR ALL JOB-ORDER EMPLOYEES INCLUDING PART-TIME TEACHERS OF THE UNIVERSITY WHO ARE NOT INCLUDED IN THE PRODUCTIVITY ENHANCEMENT INCENTIVE (PEI) PROVIDED THAT THIS IS ALLOWED BY THE DEPARTMENT OF BUDGET AND MANAGEMENT AND *SUBJECT TO* EXISTING COA RULES AND REGULATIONS

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";

WHEREAS, among other powers granted to the Board of Regents is the power "to receive and appropriate all sums as may be provided for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University" as stipulated in Section 7, Paragraph (b) of R.A. 9158;

WHEREAS, Section 4.2 (Exclusions) of Budget Circular No. 2012-3 dated 29 November 2012 issued by the Department of Budget and Management (DBM) otherwise known as "Guidelines for the Grant of the Productivity Enhancement Incentive (PEI) for 2012" excludes:

"Those hired without employer-employee relationships and paid from non-Personal Services appropriations/budgets, as follows:

- 4.2.1 Consultants and experts hired to perform specific activities or services with expected outputs;
- 4.2.2 Laborers hired through job-contracts (pakyaw) and those paid on piece-work basis;

- 4.2.3 Student laborers and apprentices; and
- 4.2.4 Individuals and groups whose services are engaged through job-orders (*JOs*), contract of services, or others similarly situated."

WHEREAS, the University, in the spirit of the Yuletide season, would like to provide its Job Order workers and part-time teachers a token package of goodies valued at not more than *Php*1,000.00 per package;

WHEREAS, the Visayas State University still has income that can be used to cover the cost of these token packages of goodies;

WHEREAS, the University Administration is requesting from the Governing Board, the authority to provide job-order workers and part-time teachers of the University with token package of goodies amounting to not more than *Php*1,000.00 per package this Yuletide season;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposal to grant a *Php*1,000.000 package of goodies to all job-order workers including part-time teachers of the University who are not included in the Productivity Enhancement Incentive (PEI) *subject to* existing rules, regulation and guidelines on this matter.

IN WITNESS of our approval thereof, we hereby affix our signatures this 11th day of December 2012 at the Visayas State University, Visca, City of Baybay, Leyte.
