A RESOLUTION CONFIRMING THE UPGRADING OF RANKS OF TEN FACULTY MEMBERS TO FULL PROFESSORS BASED ON NBC 461 4TH CYCLE EVALUATION RESULTS SUBJECT TO GUIDELINES SET BY THE DEPARTMENT FO BUDGET AND MANAGEMENT (DBM)

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, among other powers granted to the Board of Regents is the power "to appoint, upon recommendation of the President, ... and other officials and employees of the University" as stipulated in Section 7, Item (g) of R.A. 9158;

WHEREAS, the University regularly promotes academic staff whenever there are vacancies brought about by retirement of personnel;

WHEREAS, the aforementioned faculty members went through the 4th Cycle of NBC 461 and by virtue thereof, were able to qualify for Full-Professor positions;

WHEREAS, the Department of Budget and Management (DBM) provides for the upgrading of these qualified faculty members provided that they are endorsed by the governing Board;

WHEREAS, the Human Resource Management and Development Office and the University Academic Personnel Board strongly recommend their assumption to their new academic positions.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the promotions of the ten faculty members to Full-Professor Position, effective on the date indicated.
