BOR RESOLUTION NO. 92, s. 2017

A RESOLUTION CONFIRMING THE CANDIDATES FOR GRADUATION, VSU SYSTEM, FOR SUMMER SY 2016-2017, PROVIDED THAT, ALL THE CANDIDATES HAVE COMPLIED WITH ALL THE REQUIREMENTS FOR GRADUATION ON OR BEFORE THE DEADLINE INDICATED IN THE APPROVED ACADEMIC CALENDAR FOR SCHOOL YEAR 2016-2017

WHEREAS, Section 7, Paragraph (j) of R.A. 9158 empowers the Governing Board "to set policies on admission and graduation of students";

WHEREAS, Section 11 of Republic Act No. 9158 – The Academic Council - stipulates the powers of the Academic Council to wit: "... review and recommend curricular offerings and fix the requirements for the admission to the University, as well as for graduation and the conferment of degrees, subject to the approval of the Board...";

WHEREAS, a REFERENDUM was conducted *in lieu* of an *en banc* session of the University Academic Council (UAC) on account of the fact that majority of the UAC members were on Teacher's Leave;

WHEREAS, the 169 out of 187 faculty APPROVED the Referendum showing the list of candidates for graduation from the VSU Main Campus, VSU Isabel and VSU Tolosa for the Summer, SY 2017-2017, *subject to*, compliance by all the candidates, of all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2016-2017; and

WHEREAS, the UAC is strongly endorsing to the VSU Board of Regents the Confirmation of the list of candidates for graduation for Summer, SY 2016-2017 from the VSU Main Campus, VSU Isabel and the VSU Tolosa.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to Confirm the list of candidates for graduation for the Summer, SY 2016-2017 from the VSU Main Campus, VSU Isabel and VSU Tolosa, as presented, *Provided that* all the candidates shall have complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2016-2017.
