BOR RESOLUTION NO. 109, s. 2011

A RESOLUTION APPROVING THE APPOINTMENT OF MS. LOUELLA C. AMPAC TO THE POSITION OF INTERNAL AUDITOR IV (SG 22) ON TEMPORARY STATUS SUBJECT TO EXISTING CSC RULES, REGULATIONS AND GUIDELINES ON THIS MATTER

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";

WHEREAS, among other powers granted to the Board of Regents is the power "to appoint, upon recommendation of the President, ... and other officials and employees of the University" as stipulated in Section 7, Item (g) of R.A. 9158;

WHEREAS, the University regularly promotes administrative employees whenever there are vacancies brought about by retirement of the incumbent;

WHEREAS, the position of Internal Auditor IV has been vacant since year 2010 due to retirement;

WHEREAS, the Non-Academic Personnel Board has determined that Ms. Louella C. Ampac possesses all the qualifications for the assumption of the vacant item position in accordance with existing CSC policies and guidelines;

WHEREAS, the Human Resource Management and Development Office and the University Non-Academic Personnel Board strongly recommend the assumption of Ms. Louella C. Ampacto the position of Internal Auditor IV (SG-22), effective on the date indicated.

WHEREAS, the Governing Board, is convinced that the recommendations of the NAPB are fair and adhere to thrust of government that only the best and the most fit should be in the government service;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the hiring of Ms. Louella C. Ampac as Internal Auditor IV(SG-22), effective on the date indicated.
