## BOR RESOLUTION NO. 270, s. 2019

A RESOLUTION APPROVING BAC RESOLUTION NO. 257: DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB), RECOMMENDING APPROVAL OF AWARD TO THE LCRB, DECLARATION OF FAILURE OF BIDDING ON VARIOUS ITEMS, AND APPROVAL OF CHANGE OF MODE OF PROCUREMENT FROM PUBLIC BIDDING TO NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT (NP-SVP) OF THE FAILED ITEMS FOR THE SUPPLY AND DELIVERY OF CONSTRUCTION AND ELECTRICAL SUPPLIES (GOODS-19-21)

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001, and was later renamed Visayas State University (VSU) by virtue of R.A. 9437 on 27 April 2007;

**WHEREAS,** Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Directors of a corporation under Section 36 of Batas Pambansa Blg. 68 otherwise known as the Corporate Code of the Philippines";

WHEREAS, Section 7, Paragraph (f) of R.A. 9158 empowers the Board of Regents of the University "to authorize the ... acquisition of real and personal properties, including necessary supplies and equipment...";

WHEREAS, the Visayas State University (VSU) through the Bids and Awards Committee (BAC), advertised the Invitation to Apply for Eligibility and to Bid for the Project "Supply and Delivery of Construction and Electrical Supplies" with Total Approved Budget for the Contract (ABC) of Ten Million Two Hundred Fifty Eight Thousand Seven Hundred and 28/100 Pesos (P10,258,700.28) in the PhilGEPS, VSU Website's transparency seal and in conspicuous places within the premises of the Visayas State University for 23 calendar days;

WHEREAS, the Bids and Awards Committee (BAC) passed BAC Resolution No. 257, s. 2019 dated 11 November 2019 Declaring the Lowest Calculated and Responsive Bid (LCRB), Recommending Approval of Award to the LCRB, Declaration of Failure of Bidding on Various Items and Approval of Change of Mode of Procurement from Public Bidding to Negotiated Procurement – Small Value Procurement (NP-SVP) of the Failed Items for the Supply and Delivery of Construction and Electrical Supplies (GOODS-19-21);

**WHEREAS**, the BAC Resolution No. 257, s. 2019 was reviewed and endorsed by the University Administrative Council (UADCO) for approval by the VSU Board of Regents (BOR) on 13 December 2019;

**WHEREAS**, the BAC Resolution No. 257, s. 2019 was reviewed by the BOR Finance Committee during its Special Meeting held last 19 December 2019 at the Conference Room, NEDA Regional Office VIII, Government Center Palo, Leyte;

**WHEREAS**, the BOR Finance Committee is strongly endorsing for the approval of BAC Resolution No. 257, s. 2019 by the VSU Board of Regents;
