BOR RESOLUTION NO. 01, s. 2012

A RESOLUTION APPROVING THE UTILIZATION OF P9.50 MILLION RELEASED BY THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) INTENDED FOR THE CONSTRUCTION OF A NEW VSU MAIN CAMPUS LIBRARY, PROVIDED THAT THE PROVISIONS OF REPUBLIC ACT 9184 AND ITS IMPLEMENTING RULES AND REGULATIONS (IRR) ARE STRICTLY FOLLOWED

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, the Visayas State University, Main Campus, has requested a special Capital Outlay fund from the Department of Budget and Management (DBM) for the construction of a new VSU Main Campus Library;

WHEREAS, the Department of Budget and Management has released to the University the sum of P9.50 million for the construction of a new VSU Main Campus Library;

WHEREAS, Republic Act 9184, "An Act Providing for the Modernization, Standardization and Regulation of the Procurement Activities of Government and for Other Purposes" otherwise known as the Government Reform Procurement Act, including its Implementing Rules and Regulations (IRR), specify the necessary processes and steps to be undertaken attendant to the procurement of Infrastructure Projects, Goods and Consulting Services Subject to the provisions of Commonwealth Act No. 138 (Section 4, RA 9184);

WHEREAS, among other powers granted to the Board of Regents is the power "to authorize the construction and repair of buildings, machineries, equipment and other facilities and the purchase and acquisition of real and personal properties, including necessary supplies, materials and equipment..." as stipulated in Section 7, Item (f) of R.A. 9158;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to Approve the construction of a new VSU Main Campus Library sourced from the Capital Outlay funds released by the Department of Budget and Management (DBM) in the amount of P9.50 million, *Provided that*, the provisions of RA 9184 and its IRR are strictly followed.
