**BOR RESOLUTION NO. 99, s. 2011**

**A RESOLUTION APPROVING  
THE REQUEST FOR REALIGNMENT OF  
2011 BUDGET SOURCED FROM INCOME OF  
VSU ISABEL CAMPUS AND VSU VILLABA CAMPUS  
SUBJECT TO EXISTING GUIDELINES, RULES AND REGULATIONS**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "*exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines*";

**WHEREAS**, Section 7, Paragraph (B) of R.A. 9158 empowers the Governing Board "*to receive and appropriate all sums as may be provided for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University*";

**WHEREAS**, the VSU Isabel campus and the VSU Villaba Campus have determined that they are unable to implement some projects due to inadequate MOOE funds to ensure completion of the envisioned projects;


**WHEREAS**, the VSU Isabel Campus proposes to utilize the appropriated funds to pay existing part-time instructors of various courses for the period 01 September 2011 to 31 December 2011 as well as to augment the 2011 budget for various operating expenses due to the increase in the hourly rates of Job Order workers and increase in prices of basic office supplies;


**WHEREAS**, the VSU Villaba Campus proposes to utilize the appropriated funds to pay the Hazard Pay of the Public School Nurse of the Campus for the period January to December 2011 per Magna Carta for Public Health Workers as well as to augment the 2011 budget for various operating expenses due to the increase in the hourly rates of Job Order workers and increase in prices of basic office supplies;

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the request for realignment of the 2011 Budget of VSU Isabel and VSU Villaba, as proposed, effective upon Board approval, *subject to existing guidelines, rules and regulations.*




