**A RESOLUTION APPROVING
THE MEMORANDUM OF AGREEMENT
BETWEEN THE LEYTE STATE UNIVERSITY
AND JOVIANE'S DRUG TESTING LABORATORY**

WHEREAS, the Leyte State University is a public higher education institution (HEI) established under Presidential Decree 470 as amended by Presidential Decree 700 and converted into a state university by virtue of Republic Act 9158 duly represented by its President, Dr. Paciencia P. Milan;

WHEREAS, Joviane's Drug Testing Laboratory is an authorized drug testing center by the Department of Health, represented herein by Ms. Jessica Tagpis-Abit;

WHEREAS, the First Party requires the services of a drug testing center to perform the required drug testing of its faculty and students as part of their annual physical examination and that the University Infirmary does not have the facilities for this;

WHEREAS, the Second Party is offering to bring its drug testing services to the Main Campus, it being an authorized drug testing laboratory at a much reduced cost of P200/employee;

WHEREAS, LSU faculty and students have to go to either Baybay or Ormoc to have their annual drug test;

WHEREAS, the Second Party is willing to pay the cost of electricity, water and office space while inside the University Infirmary at the rate of P35.00/employee.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the Memorandum of Agreement between the Leyte State University and Joviane's Drug Testing Laboratory, as presented.


