**BOR RESOLUTION NO. 70, s. 2010**

**A RESOLUTION APPROVING  
THE CREATION OF NEW ACADEMIC POSITIONS**

**WHEREAS**, Section 7, Paragraph (a) of R.A. 9158 empowers the Governing Board *“to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University”*;

**WHEREAS**, the Department of Budget and Management (DBM) has advised all government agencies that budgetary allocation for unfilled positions will only be released once these are filled-up;

**WHEREAS**, the University has a few high-level academic positions which have become vacant as a consequence of the retirement of academic faculty holding these positions;

**WHEREAS**, the VSU Human Resource Management Office has ascertained that with the present manpower complement of the VSU, these high-level positions cannot be filled-up due to lack of qualified candidates;

**WHEREAS**, the Academic Personnel Board has gone over the proposal during its 18 August 2010 Meeting and has recommended the abolition of the aforementioned high-level academic positions in exchange for Instructor I positions;


**WHEREAS**, the VSU Human Resource Management Office has proposed to the DBM for the conversion of 12 high-level academic positions into 20 Instructor I positions;


**WHEREAS**, the DBM issued a Notice of Organization, Staffing and Compensation Action (NOSCA) dated 01 December 2009 for 12 Instructor I positions and a supplemental NOSCA for another 8 Instructor I positions;


**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the creation of 12 new Instructor I positions pursuant to DBM NOSCA No. 0802009-11-019 dated 01 December 2009 and the creation of another 8 new Instructor I positions pursuant to the supplemental DBM NOSCA No. 0802010-08-013 chargeable against balance of the abolished positions per NOSCA No. 0802009-11-019.




