BOR RESOLUTION NO. 03, s. 2020

A RESOLUTION COURSED THROUGH REFERENDUM APPROVING THE REQUEST TO DEFER THE EFFECTIVITY DATE OF THE SABBATICAL LEAVE OF DR. OBDULIA G. CAMOYING FROM 01 FEBRUARY 2020 UNTIL 31 DECEMBER 2020 TO 01 MARCH 2020 UNTIL 31 DECEMBER 2020

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001, and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Paragraph (h), Section 7 of RA 9158 provides, to wit: "... to grant them, at its discretion, leaves of absence under such regulations as it may promulgate, any provisions of the existing law notwithstanding ...":

WHEREAS, the faculty and staff of state universities and colleges belong to the "closed career positions of the Civil Service", being scientific or highly technical in nature, and as such are mandated to establish and maintain its own merit system;

WHEREAS, sabbatical assignment is granted to qualified members of the faculty to encourage study, investigation, research, and to improve staff competencies for improved efficiency;

WHEREAS, the Sabbatical Leave application of Dr. Obdulia G. Camoying effective 01 January 2020 to 31 December 2020 was approved by the Governing Board through VSU BOR Resolution No. 240, series of 2019;

WHEREAS, the request of Dr. Camoying to defer the effectivity of her approved Sabbatical Leave from 01 January 2020 until 31 December 2020 to 01 February 2020 until 31 December 2020 was approved by the Governing Board through VSU BOR Resolution No. 467, series of 2019;

WHEREAS, VSU Pres. Edgardo E. Tulin submitted a letter requesting the VSU BOR to defer the effectivity of Dr. Camoying's Sabbatical Leave from 01 February 2020 until 31 December 2020 to 01 March 2020 until 31 December 2020 in view of the time constraint associated with changing of signatories in Finance transactions for the VSU Tolosa Campus, and in connection with the ISO Audit on 19-20 February 2020;

WHEREAS, Dr. Camoying indicated her agreement through her signature as conformee in the abovementioned letter-request submitted to the VSU BOR by Pres. Tulin;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to **Approve** the request to defer the effectivity date of the Sabbatical Leave of Dr. Obdulia G. Camoying from 01 February 2020 until 31 December 2020 to 01 March 2020 until 31 December 2020.
