BOR RESOLUTION NO. 24, s. 2016

A RESOLUTION COURSED THROUGH REFERENDUM
APPROVING THE PROPOSAL TO SPLIT THEIR REMAINING 5-UNITS
OF THE HRTM 200 (INDUSTRY PRACTICE) COURSE INTO 2-UNITS DURING
THE TRANSITION PERIOD – JUNE 2016 TO JULY 2016 - AND THE REMAINING
3-UNITS DURING THE 1ST SEMESTER, SY 2016-2017

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, Section 7 of RA 9158 provides: "The Board shall have the following specific powers and duties in addition to its general power of administration and the exercise of the powers granted to the Board of Directors of a corporation under Section 36 of the Batas Pambansa Blg. 68, otherwise known as the Corporation Code of the Philippines";

WHEREAS, Section 7, Paragraph (a) of R.A. 9158 empowers the Governing Board "to enact rules and regulations as may be necessary to carry out the purposes and functions of the University...";

WHEREAS, the Governing Board passed BOR Resolution No. 69, s. 2015 dated 10 October 2016 approving the shift in the opening of classes for SY 2016-2017 from June 2016 to August 2016;

WHEREAS, the shift in the opening of classes for SY 2016-2017 necessarily created a transition period, covering the months of June 2016 and July 2016, which is not included in the academic calendars of either SY 2015-2016 or SY 2016-2017;

WHEREAS, the 7-unit load for HRTM 200 (Industry Practice) is divided into 2-unit load and 5-unit load, with the 2-unit load taken up during the summer and the remaining 5-unit load taken up during the 1st Semester of the following school year;

WHEREAS, the Department of Consumer and Hospitality Management (DCHM) has requested that for the 2016 transition period, it would like to further breakdown the remaining 5-unit HRTM 200 course load into: a) 2-units, to be taken up during the transition period; and b) 3-units, to be taken up during the 1st Semester of SY 2016-2017;

WHEREAS, the BSHTRM major students taking up HRTM 200 – Industry Practice (5 units) have to be deployed in the different establishments for the purpose of their Industry Practice which comprise about 400 hours, starting in June 2016 lest they be disadvantaged unnecessarily;

WHEREAS, Section 11 of R.A. 9158 indicates that the Academic Council has the power to "recommend curricular offerings and fix the admission to the University, as well as for graduation and the conferment of degrees, subject to the approval by the Board";

WHEREAS, the University Academic Council, by way of a referendum, approved the proposal of the Department of Consumer and Hospitality Management for the break-up of the 5-unit load, as proposed, and is strongly endorsing the same to the VSU Board of Regents for Approval.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to **Approve** the proposal to split the remaining 5-units of the HRTM 200 (Industry Practice) course into 2-units during the transition period – June 2016 to July 2016 – and the remaining 3-units during the 1st Semester, SY 2016-2017, as presented.
